Good afternoon, Mr. Nelsen,

We received your request on Wednesday, May 24, asking for:

1. Copies of all grievances filed by the State against SEIU 775 from January 1, 2013 to July 1, 2015.
2. Copies of all grievances filed by SEIU 775 against the State from January 1, 2013 to July 1, 2015.

Under the Public Records Act, chapter 42.56 RCW, I reply on behalf of the agency. For part (1) of your request, please note that staff informs me there is no mechanism for the state to file grievances against a union, and therefore we will not have records responsive to your request. However, if there is something in particular you are looking for related to this part of your request, we may be able to help you track it down if you can provide further clarifying information.

For part (2), we have begun a search for responsive records. Based on staff schedules and the number and type of records you have requested, I estimate we can provide responsive records by June 16, 2017.
