Aisling,

### **January 7th meetings:**

I spoke to Stacey on Wednesday and here is where things are and some thoughts I have.

--She has offered up a 30 min morning mtg for the discussion on income inequality that I am offering up to Adam Glickman to coordinate

--She was not able to do anything before January 7th for meetings that are not urgent (given budget rollout, holidays), so she is offering up that morning to Lani as well for the Harris v Quinn discussion with 925. I have asked Diane Lutz to hold that time on her calendar.

--She got the message that SEIU has asked for an hour time slot, she will wait until I get back to her from building trades. I have not heard back from Dave, so will call him tomorrow and see where he is at with a meeting.

-----One concern I have with this set up is that if we give them twice the amount we are giving the building trades do we have a fair reasoning for that? I am just guessing that it will get out that they get an hour, but I might be wrong, you would know better than I. Let me know if you think 45 minutes for each group would serve us better. I could argue that the SEIU's issues are so varied that it warrants the 60 min, but then again we are meeting 775 and 925 earlier that morning. When I talk to Dave tomorrow I will only offer up the 30 min. unless you think differently after this information above.

### **Preparation for meetings:**

To be honest when Kirstan sent the request I didn't take them as my meetings but as those you proposed we have so that stakeholders could have face time before session; sorry for the misunderstanding. That being said, of course I will work with the stakeholder leads to make them as valuable as it can be for both the groups and the Governor.

I will work with Mike so that the SEIU's not only bring up issues that are unique to each of them but those that they share. Regarding the building trades, I will work with Dave to do the same. Based on what they will cover, I will be sure that the Governor is prepared and will suggest what he may want to raise as his priorities.

### **Grain:**

I am sending an email shortly to you and Joby about what I advise for next step/meetings. I am talking to one of ILWU negotiators tomorrow. I don't believe that will make much of a difference, but since I am talking to folks at UGC who are at the table, it makes sense. Dan is good about updating but he is not at the table.

### **Port Bathrooms:**

After meeting with the advocates and then with you, Richard said that he would reach out to the Teamsters and let them know you both had decided that the Governor would not include it in their budget. Based on an email that Majken sent me, it is clear he has not done that. I am a little concerned that based on the email this denial will be a surprise and that is not the impression I have gotten from Richard. The advocates shared with me that Richard has been handling this successfully so I only raise this because he is leaving and I have not been involved with this at all. Anyway, you will see an email that asks Richard to please check in with them before he leaves, so that I am not in an awkward situation. Whatever you can do to encourage that communication happens, is very much appreciated.

I mainly wanted to mention this because I am fairly sure we are going to disappoint them regarding extending interest arbitration to other groups, so I am trying to anticipate some stakeholder management issues.
