- Budget monitoring in accordance with Association guidelines and procedures.
- · Recordkeeping and reporting in compliance with legal requirements for agency fee.
- Training sessions for affiliate financial representatives and staff in the areas of membership processing, general accounting, and other financial areas.
- Development, maintenance and analysis of the CTA membership database and connected systems that support the programs and services of the Association.
- Identify opportunities and implement processes to provide member information via the web.
- Implement systems and processes that provide efficiencies and make better use of the Association's assets.

Prepare and distribute an accounting manual to assist Treasurers of affiliated organizations and conduct financial training to provide fiduciary guidelines to local leaders.
