Dear President Lanigan:

This letter serves as OPEIU HEALTHCARE Pennsylvania, OPEIU 112's formal request to the International for its approval to merger with OPEIU Local 153. I have previously discussed with you that the continued viability depends on its decision to merge with a larger OPEIU Local.

Numerous factors have entered into reaching this decision. Local 112 has continued to lose membership through facility closures, the *Janus* Decision, shrinking hospital services, etc. With my decision to retire on December 31, 2020, that also impacts the future of Local 112.

The Board of Directors of Local 112 has thoroughly discussed various options and it reached the decision that merging with OPEUIU Local 153 is the best course of action for Local 112's future. The Local 112 Board of Directors met via teleconference on November 9th and passed a Board Resolution seeking and approving that OPEIU Local 112 merge with OPEIU Local 153.

On behalf of the Board of Directors, I am respectfully requesting that the OPEIU approve this requested merger and assist in facilitating an expedient merger of the two Locals.

The Proposal to Merge OPEIU Local 112 with OPEIU Local 153

An election by secret ballot is being conducted among the eligible members of OPEIU, Local 112. A ballot, secret ballot envelope and a ballot return envelope are enclosed. To vote, read the packet carefully and carry out the following instructions:

YOUR BALLOT MUST BE MAILED SO THAT IT REACHES THE BALLOT COMMITTEE NO LATER THAN THE CLOSE OF BUSINESS March 12, 2021. We recommend that you mail your ballot no later than March 2, 2021.

Local 112 will use its accountant to open and tally the merger ballots.

- 1. Read the enclosed ballot carefully before marking
- Mark an (X) in the box next to your choice. Vote for <u>one choice</u> either <u>ACCEPT</u> the proposal to Merge Local 112 with Local 153; or <u>REJECT</u> THE PROPOSAL TO MERGE Local 112 with Local 153.
- 3. Fold the ballot and insert it in the envelope marked "Secret Ballot Envelope". Seal the envelope. Do not write your name on "Secret Ballot Envelope" envelope.
- Insert secret ballot envelope into the larger ballot return envelope which is addressed to OPEIU LOCAL 112, 425
 N. 21th Street Camp Hill, PA 17011.
- Sign your name clearly. Seal the mail ballot return envelope and write the location where you are employed on the line across the back flap of the larger ballot return envelope addressed to <u>OPEIU LOCAL 112, 425 N. 21th</u> <u>Street Camp Hill, PA 17011.</u>

<u>DO NOT</u> WRITE YOUR NAME ON THE BALLOT OR THE <u>"SECRET BALLOT ENVELOPE"</u>. THIS WILL VOID YOUR BALLOT.

If the larger ballot reply envelope does not contain your name, your ballot will be "VOID". <u>Your vote is secret</u>. Your name will only serve the purpose of verifying your eligibility to vote. The larger ballot reply envelope addressed to "Local 112 Accountant" will be separated upon receipt and the sealed "Secret Ballot Envelope" containing your ballot will be deposited with all other ballots so that when it is opened and counted there will be no possibility of identifying you with the ballot.

The OPEIU HEALTHCARE Pennsylvania Board of Directors requested that I tally the ballots cast on the proposed merger between OPEIU HEALTHCARE Pennsylvania, Local 112 and OPEIU Local 153.

I traveled to the Local 112 offices on March 12, 2021 where the ballots were received and held prior to the count. OPEIU HEALTHCARE PA Board President, Janeen Davis, was present and assisted in the tally and recordation of the Ballot Count. Executive Director Michael Bodinsky was also present at the tally as a witness to the process.

The total number of ballots received was 156. Four (4) ballots were voided for lack of membership verification. A total of 152 ballots were validated and counted.

The total number of Ballots cast in opposition to the proposed merger:	6 No	
Two additional Ballots voided during count	2
